**Civil society and Indigenous Peoples' appeal to the FAO Council
to rescind the FAO partnership agreement with CropLife International**

Dear Member State Representatives of the UN FAO Council,

We would like to take the opportunity to urge you to bring forth in the discussion of the Strategy for Private Sector Engagement in the upcoming 170th FAO Council Session (13-17 June 2022) the strong recommendations of civil society, Indigenous Peoples and the UN Special Rapporteur on the Right to Food for the FAO to review and rescind its existing [partnership agreement](#) with CropLife International (CLI).

In a [report](#) made to the 49th Session of the UN Human Rights Council, UNSR Michael Fakhri recommended the FAO Council “*to review the agreement with CropLife International with an eye to human rights concerns*” and “*to consider directing the Director-General of FAO to rescind the agreement.*”

We urge you to act urgently on these recommendations. CLI is a global trade association whose members are the world’s largest agrichemical, pesticide and seed companies: *BASF, Bayer Crop Science, Corteva Agriscience, FMC and Syngenta*. CropLife International member companies make [over one-third \(35%\)](#) of their sales from Highly Hazardous Pesticides (HHPs) — the pesticides that pose the highest levels of risk to health and the environment.

We believe that FAO’s agreement with CropLife International is **incompatible with FAO’s obligations to uphold human rights**. The use of hazardous pesticides is inconsistent with the rights protected by the United Nations to: *Health; Clean, healthy and sustainable environment; Safe working conditions; Adequate food; safe and clean water and sanitation; A dignified life; and Rights of Indigenous Peoples, women, children, workers, and peasants and other people working in rural areas.*

We are concerned with how CLI member companies have interfered in national policy and exert enormous pressure on governments that take measures to protect people and the environment from pesticide harms. As [pointed out](#) by former UNSR on the Right to Food Hilal Elver in 2017, “The pesticide industry’s efforts to influence policymakers and regulators have obstructed reforms and paralysed global pesticide restrictions globally.” Recent examples are how CLI and Bayer [influenced Thailand’s decision](#) to overturn a ban on the cancer-causing glyphosate, and applied similar lobbying tactics to [pressure Mexico](#) to drop a decree to phase-out glyphosate and GMOs.

It cannot be ignored that as profit-driven corporations, CropLife International’s primary aim is to maximize sales of their members’ products, especially in the Global South. CLI member companies [explicitly target](#) countries in Africa, Latin America and Asia, where the proportion of their HHP sales is even higher. **FAO deepening its collaboration with CropLife International directly counters any efforts toward progressively banning HHPs, as [recommended](#) for consideration by the FAO Council as early as 2006.** The FAO and WHO Code’s [Guidelines on](#)

[HHPs](#) recommends phasing out and ending the use of HHPs through banning, canceling or withdrawing registration, and “ending use” as a mitigation option.

Further, FAO’s partnership with CropLife International undercuts the FAO and several Member States’ [support for agroecology](#), an approach that offers viable and sustainable proposals for generating ecologically-based food and farming systems without the use of toxic pesticides.

In the year and a half since the Letter of Intent between FAO and CLI was signed in October 2020, civil society and Indigenous peoples have submitted [various letters](#) of appeal to the FAO leadership, including a [global petition](#) signed by over 187,300 individuals from more than 107 countries. However, to date, Director General Qu has not addressed the calls from rights holders, [scientists and academics](#), [funders](#) or even the UN Special Rapporteur on the Human Right to Food to rescind this agreement. **Therefore, today we elevate our concerns to the FAO Council as the governing body which can properly address this urgent matter.**

The FAO’s new due diligence framework (FRAME) under its Strategy for Engagement with the Private Sector outlines a specific set of criteria for assessing potential private sector partnerships. It should be pointed out that FAO’s partnership with CLI was entered prior to the adoption of FRAME, therefore, it is unclear whether it was evaluated through an adequate due diligence screening. If CropLife International were to be evaluated on such criteria now, e.g. Exclusionary Criteria, which lists companies involved in **human rights abuses** as excluded from potential partners; and reputational risk criteria which checks companies’ alignment to Environmental, Social and Governance components (page 17 and Appendix I, II, and III of *FAO Strategy on Private Sector Engagement – Updates and Implementation Status PC 132/2*), it is unlikely that it would be deemed fit for a partnership with the FAO without undermining the FAO’s integrity, credibility, impartiality, independence and neutrality.

With the FAO and its Member States’ crucial role in enacting and promoting policies to reduce reliance on toxic pesticides, the FAO Council must not allow the agency to continue its partnership with CropLife International through an LOI or any other engagement mechanism. FAO Director General Qu Dongyu has [said](#) that prior to the partnership, the agency had already been working with CLI on the “on the removal of highly hazardous obsolete pesticides.” The FAO should continue to ensure that the pesticide industry fulfill its obligations to clean up the planet, not enter into a broad-ranging agreement to collaborate on “[expanded areas of engagement](#)” in line with the FAO’s private sector strategy.

We respectfully urge Members of the FAO Council to call on the agency leadership to instead prioritize the increase of farmer access to agroecological practices and tools that help them grow their crops sustainably without harming their health. **To safeguard the health and well-being of the people and the planet, we call on the Council to direct the Director-General to end FAO’s partnership with CropLife International.**
